



RURAL MUNICIPALITY OF ROSEDALE

BY-LAW NO. 7-2019

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF ROSEDALE FOR THE PURPOSE OF AUTHORIZING APPOINTMENTS AND REMUNERATION OF THE MUNICIPAL OFFICIALS.

WHEREAS it is deemed expedient and necessary to appoint officers for the Municipality of Rural Municipality of Rosedale.

NOW THEREFORE the Reeve and Councillors assembled in Council, enact as follows:

1. **THAT** each Councillor receive an indemnity of \$700.00 per regular meeting together with mileage of \$.50 per kilometer or \$.80 per mile and that the Reeve shall receive an indemnity of \$750.00 per regular meeting together with mileage of \$.50 per kilometer or \$.80 per mile in addition to \$15.00 per meeting as a lunch allowance.
2. **THAT** each Councillor and the Reeve shall receive an indemnity of \$50.00 per month as a cell phone allowance.
3. **THAT** each Councillor shall be a Commissioner in his own ward for the performing or the superintending of the Public Works within his own ward. Remuneration \$20.00 per hour and mileage of \$.50 per kilometer or \$.80 per mile.

REGULAR COUNCIL MEETING DAY

4. **THAT** the Rural Municipality of Rosedale's regular Council meeting day be the second Friday in each month commencing at 10:00 am in the Rosedale Municipal Office, Neepawa, Manitoba.
5. **THAT** the organizational meeting of Council in any year shall be, for the purpose of this by-law, an additional regular meeting and the Reeve and Councillors shall be paid the same as they are paid for a regular meeting.

SPECIAL COUNCIL & COMMITTEE MEETINGS

6. **THAT** an additional remuneration of a minimum of \$50.00 for any special meeting attended and that any meeting attended for more than 2 hours receive a rate of \$20.00 per hour.

FIRE


7. **THAT** each Councillor shall be Fire Guardian for his own ward and the Reeve shall be Chief Fire Guardian for all wards. Remuneration shall be for the Fire Guardian \$20.00 per hour and \$.50 per kilometer or \$.80 per mile.

SOLICITOR


8. THAT Taylor Law Office be retained as lawyer for the Municipality and be paid a retainer fee of \$200.00 each year.

9. THAT By-Law 12-2018 be repealed as the date on which this By-law comes into effect.
