BE IT RESOLVED THAT we do now open this Public Hearing of council at 7:00 p.m. to hear representation regarding Local Improvement Plan 2021-02 – By-Law No. 2-2021 for the proposal to establish a Special Service Levy to help offset the maintenance and operational costs of the Birnie Community Club. ## R.M. of Rosedale By-Law No. 2-2021

- Reeve Michael Porrok provided a brief introduction of Council members and an overview of the Special Service Proposal By-Law No. 2-2021 Public Hearing regulations. He then asked if there were any questions or objections.
- David Todoruk requested clarification and Council responded by providing information that the Birnie Community Club required financial assistance with the operating costs of the Hall beginning in 2019. A new committee has been formed and they have held two fundraising events in 2020 to generate revenue.
- John McConnell provided financial information regarding the current balance of approximately \$7,000 with half being raised by grant funding and

- that there are still bills outstanding that have yet to be received/paid such as grass cutting for the year and septic repairs/maintenance.
- Alan Butterfield suggested the committee registers as a non-profit organization so tax receipts can be issued for donations. Requested more information about bank statements and outstanding bills.
- Kelly Wilson stated that the committee has worked hard to raise additional funds but that events have been delayed due to COVID-19 and that members are willing to continue to sell vouchers and participate with future fundraising ideas.
- Don Smith suggested that Council should focus their efforts on the more frequently used and updated community halls within the municipality. He asked for clarification of the number of times the hall has been used/rented in recent years and how much the rentals fees are for each use. Council responded that the hall was rented approximately 3 times in 2019 for \$75.00 on each occasion and that the Nursery pays rent for use of the hall as well as funding is provided by Council through grants/VLT funds each year as is with many other halls throughout the municipality. Mr. Smith suggested that the Nursery school relocate to Riding Mountain or Eden Halls. Council response was that the Birnie Hall is currently up to date with all Fire Codes and Child Care Regulations in Manitoba and that relocating would cause inconvenience and additional expense.
- Jeff Braun provided a brief update regarding the walk through inspection of the building completed last year. The building was viewed to be structurally sound and that other than a few updates and maintenance suggestions, there were no issues with the condition of the building.
- Kim Lukin stated that the hall is not used for a number of the events listed on the notice and that she does not personally use the hall.
- Janet O'Donnell requested clarification of VLT funds approved by Council
  and suggested that the municipality apply for grants to assist with operating
  costs.
