

RURAL MUNICIPALITY OF ROSEDALE

By-law No. 5-2021

REMUNERATION BY-LAW

BEING A BY-LAW FOR THE PURPOSE OF ESTABLISHING REMUNERATION AND REIMBURSEMENT OF EXPENSES FOR MEMBERS OF COUNCIL.

WHEREAS Part 3 Division 6 of The Municipal Act, C.C.S.M., c.M225, Section 124 authorizes the Council of a municipality to set the types and rates and conditions of payments to be made to or on behalf of Members of the Council and Council Committees;

NOW THEREFORE the Council of the Rural Municipality of Rosedale enacts as follows:

1. **THAT** each Councillor receive an indemnity of \$700.00 per regular meeting together with mileage of \$.50 per kilometer or \$.80 per mile and that the Reeve shall receive an indemnity of \$750.00 per regular meeting together with mileage of \$.50 per kilometer or \$.80 per mile in addition to \$15.00 per regular meeting as a lunch allowance.
2. **THAT** each Councillor and the Reeve shall receive an indemnity of \$50.00 per month as a cell phone allowance.
3. **THAT** the organizational meeting of Council in any year shall be, for the purpose of this by-law, an additional regular meeting and the Reeve and Council members shall be paid the same as they are paid for a regular meeting.

SPECIAL COUNCIL & COMMITTEE MEETINGS

4. **THAT** each Councillor shall be a Commissioner in his own ward for the performing or the superintending of the Public Works within his own ward. Remuneration \$20.00 per hour and mileage of \$.50 per kilometer or \$.80 per mile.
5. **THAT** each Council member shall be Fire Guardian for his own ward and the Reeve shall be Chief Fire Guardian for all wards. Remuneration shall be for the Fire Guardian \$20.00 per hour and \$.50 per kilometer or \$.80 per mile.
6. **THAT** an additional remuneration of a minimum of \$50.00 for any special meeting attended and for more than 2 hours receive a rate of \$20.00 per hour for a total of \$170.00 per 8 hour day; in addition to up to \$10.00 for breakfast, \$15.00 for lunch and \$20.00 for dinner allowance.
7. **THAT** members of council shall at their regular meeting of council, submit an account for monthly, daily and hourly compensation and expenses for their attendance at meetings in the previous month. Such account shall specify the date of the meeting, the type of meeting, its general purpose, the travelling expense incurred, complete with receipts as required, and such

account for compensations and expenses shall be verified under statutory declaration and signed by the member of council, and submitted to the Chief Administrative Officer.


8. **THAT** The Signing Officers of the municipality shall not pay out any claim or accounts for compensation or expenses to members of council unless duly approved by Council.


8. **THAT** Taylor Law Paterson LLP be retained as lawyer for the Municipality and be paid a retainer fee of \$200.00 each year.
